INFORMATION TO WEBSITE'S USERS FOR THE PROCESSING OF PERSONAL DATA

1. Nature of the data processed

- Navigation data / e-mail

The information systems and software procedures used to operate this website acquire, during their normal operation, some personal data transmitted while using Internet communication protocols. This information is not collected to be associated with identified interested parties, but by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of the computers used by users connecting to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters relating to the operating system and the user's computer environment.

- Data provided voluntarily by the user

Sending emails optionally, explicitly and voluntary to the e-mail address on this site entails the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the message.

2. Purpose of the treatment

The navigation data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct operation. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site

3. Legal bases of processing

The navigation data, technical cookies and analytics and technical information strictly necessary to provide the service will be processed as necessary to pursue the legitimate interest of F.LLI GANDOSSI ACCIAIERIE ELETTRICHE S.P.A. to website publication and management.

Data relating to e-mail communications will be processed on the basis of the consent expressed by users.

4. Processing methods and data retention period

Data processing will be carried out either manually or with the aid of IT and telematic means. The data will be stored in electronic files for the time strictly necessary to achieve the purposes referred to in paragraph 2 and in any case, following the exhaustion of these purposes, up to a maximum of one year. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

7. Rights of the interested party

The privacy legislation (articles 12-22 of EU Regulation 679/2016) guarantees the right to be informed about the processing of data concerning you, and the right to access the data at any time and request the update, integration and correction. If the conditions provided for by the law are met, the data subject may also claim the right to cancel data, limit their processing, data portability, opposition to processing, and not be subjected to decisions based solely on automated processing.

If the processing of personal data is based on the consent of the person concerned, he / she has the right to revoke the consent given.
